What is a Cookie?

Cookies are small text files stored on your computer or mobile device when you visit our website. We use cookies to better understand how people use our services, improve them, and determine whether our emails are being read and are useful. The information stored in cookies is not linked to any personally identifiable information you provide while on our site.

Types of Cookies We Use

1. ***Session ID Cookies:*** These cookies facilitate site navigation and last only for the duration of your online session. They are deleted from your device once you close your browser (e.g., Internet Explorer, Safari).
2. ***Persistent Cookies:*** These cookies remain on your device for an extended period. You can remove them through your browser's help menu. Persistent cookies allow us to track user interests to enhance your experience on our site
3. ***Google Analytics Cookies:*** These cookies help us understand website traffic and user behavior. They enable us to improve our website and digital marketing efforts while identifying any issues. The data collected is anonymous and includes visitor counts, sources of traffic, and pages visited. 4. ***Cookie Preference Cookies:*** These cookies store your preferences about cookie usage on our website, ensuring consistency in your experience.
5. ***Traffic Log Cookies:*** These cookies analyze webpage traffic to help us tailor the site to customer needs. The information is used for statistical purposes and removed once analyzed.
6. ***Social Media Cookies***
